THE 2025 TAX YEAR:

Key Changes to be aware of:

- -Due to our increased bank processing fees, fee from refund services will incur an additional fee of \$21 per fee from refund. If you pay via EFT you won't incur this fee.
- -The instant asset write off for small business is still just \$20,000 (excluding GST price) per asset.
- -The concessional superannuation contribution cap for this financial year is \$30,000 per taxpayer. You may also be eligible to use some carry forward concessional contributions, if you haven't used up all your prior year caps.
- -When selling a property in Australia, the person(s) on the title need to obtain a foreign capital gains tax withholding certificate. Failure to do so before settlement means that 15% withholding tax applies on the sale.
- -Increased funding for ATO compliance: the Labor government has directed more funding to the tax office which means that we would expect more random audits this financial year. Our advice is to ensure that you keep all your receipts and records in a safe and secure place!
